



FSM PASSPORT REQUIREMENTS:

1. A person applying for a FSM Passport must complete two (2) sets of the attached application form and forward them to the address as shown below:

2. The completed application forms must be notarized by a notary public;
3. Submit two (2) recent Passport-size photos (1.5" X 1.5"), color or black & white. (First time applicants must submit three photos).
4. Photos must be signed on the bottom front of the photo and the signature must agree with the signature on the application.
 - a. Photos must clearly show the applicants face; following photos are not accepted:
 - use of sunglasses or shades
 - use of sleeveless shirts or tanktops
 - use of large combs or other articles that stick visibly out from hair
 - use of leis, earrings, necklaces or other distracting decorative items
 - official/diplomatic applicants must wear appropriate attire
5. Submit \$50.00 in money order or cashier's check payable to the FSM Treasurer. No cash or personal check will be accepted.
6. Please note that applications for replacement of lost passport, must be accompanied by notarized affidavit of lost passport (see sample attached). Replacement fee for loss of the new passport is \$75.00.
7. Submit a notarized copy of your birth certificate (First time applicants only).
8. The FSM Embassy in Washington, D.C. strongly recommends that passports be kept current at all times. When applying for a new passport, please keep your I-94 in a safe place and attach it in your new passport upon receipt. Do not lose your I-94 card.

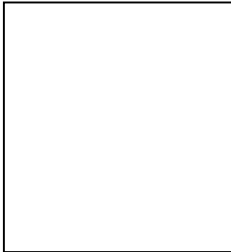
